

Rahul says no, Congress may go for non-Gandhi president

NEW DELHI: Even in election week, the stalemate over who will be the next Congress chief shows no signs of a breakthrough, the NDTV reports.

The latest efforts to sway Rahul Gandhi to accept the role have been fruitless, sources said. He has been steadfast in his reluctance, turning down the appeals by members since resigning after the 2019 general election debacle.

Sonia Gandhi too has ruled out returning as President because of her health.

That has shifted the focus to Priyanka Gandhi Vadra as most members of the 137-year-old outfit are still keen on rallying around a Gandhi, sources said. But her disastrous record in this year's Uttar Pradesh election weighs on the minds of many.

Rajasthan Chief Minister Ashok Gehlot, 71, is among many names being considered for Congress chief, sources said, which means the new party president is likely to be a non-Gandhi leader.

Confounded by the lack of a consensus, the schedule for the Congress's presidential election due to start today is clouded by uncertainty.

The party has not officially commented on the gridlock.

"Yes, he (Rahul Gandhi) has said he is not interested, but we are working on him and requesting him to take over. He will have to tell us then how this post will be filled," Congress veteran Bhakta Charan Das told the news channel.

Rahul Gandhi, however, continues to lead the Congress's campaign against the government. He is set to address a massive rally in September and will start the "Bharat Jodo Yatra" from Kanyakumari.

"Yes, we are organising a rally and Rahul Gandhi will be leading. We are not sure



of the presidential election, though," former Haryana chief minister Bhupinder Singh Hooda said.

The Congress's leadership crisis has been simmering for years and has only worsened with its back-to-back election defeats and string of exits by high-profile leaders.

In March, Sonia Gandhi in her speech to senior leaders at a meeting to discuss the party's assembly election defeats had offered to resign along with Rahul Gandhi and Priyanka Gandhi Vadra. However, she was persuaded to stay on till the elections. The last time the Congress had a non-Gandhi was in 1998 in Sitaram Kesri.

India delivers fresh batch of medical supplies to Kabul
